Under the provisions of Section 21 of the Tamil Nadu Value Added Tax Act, 2006 and sub-rule 5 of Rule 7 of the Tamil Nadu Value Added Rules, 2007, it is hereby ordered that 42,475 dealers as per the list enclosed in addition to the dealers already mandated in the references cited shall file the returns (i.e. Form I, K, L (Vatable goods), Form J (Non-Vatable Goods) and Form-1 (CST Act)) electronically (e-filing) through the Commercial Taxes Department's website [www.tnvat.gov.in](http://www.tnvat.gov.in) on or before the due dates. They shall start filing their returns electronically from the month of May 2009 (April 2009 Returns). These dealers shall continue to file the Hard copy of their monthly returns along with proof of payment of tax in their respective Circles till comprehensive e-service is provided.

The regulations which shall be followed for filing the monthly returns online are given in the Annexure.

## ANNEXURE

### The regulations for filing of Monthly Returns online through website

1. The above said dealers shall file their respective monthly returns online along with the annexures on or before the due date prescribed for them.
2. The User manual for filing of Returns online is available in the Website [www.tnvat.gov.in](http://www.tnvat.gov.in) which may be used to learn about e-filing of Returns.
3. The dealers shall access this Website only for lawful purposes and shall be responsible for complying with all applicable laws, statutes and regulations in connection with the use of this website.
4. They shall use this service to file monthly returns for under TNVAT Act (for Vatable goods, Non-Vatable goods) and CST Act.
5. The Users shall complete all the process and steps required for the submission of monthly returns online. The successful submission of monthly returns can be ascertained once the acknowledgement is generated through the website. Commercial Taxes Department shall not be responsible in any way for incomplete or defective submission of the monthly returns through online.
6. The Dealers are entirely responsible for all the content that they have entered / uploaded, posted, e-mailed through our website to the Commercial Taxes Department. The Department does not control the content entered / posted via the website by the dealers and as such does not guarantee the accuracy, integrity or quality of the contents. Under no circumstances will Commercial Taxes Department be liable in any way for any content including, any errors or omissions or any loss or damage of any kind incurred as a result of the use of any content posted, e-mailed or otherwise transmitted through the website. Recognizing the Global nature of the Internet, the dealers shall comply with all the rules regarding online conduct and acceptable content.
7. The dealers shall check their monthly returns filed online for errors, if any, immediately after the printing of draft reports which should be done soon after the confirmation of the filing but before the selection of "submit" button.
8. It shall be the dealer's responsibility to comply with the System requirements, like Hardware, Software and Internet connectivity to access the Commercial Taxes website for filing of Returns online.

9. Commercial Taxes Department will try its best to ensure that its website functions properly. But any failure of any equipment or Software at our end or Internet connectivity shall not entitle the dealer for any loss or damages.
10. The website has reasonable security measures in place to protect against the loss, misuse and alteration of information under our control.
11. This website just provides one more channel for filing of monthly return through the medium of Internet.
